# A Technical Analysis of Assam University Academic Frameworks: Examination Patterns, Pedagogical Resources, and Admission Systems

## Navigating the Digital Repositories: IDR and AULISAA

Assam University has transitioned toward digital infrastructure to support its student body. The **Institutional Digital Repository (IDR)** and the **Assam University Library & Information Science Alumni Association (AULISAA)** serve as the primary gateways for academic data. These systems utilize specific metadata structures to organize thousands of documents.

### Search and Retrieval Workflow in IDR

Efficient retrieval of **PG and UG question papers** from the IDR system follows a logical technical path:

1. Authentication: Accessing the community home page (often linked to the Library & Information Science department).
2. Keyword Indexing: Users must input specific parameters such as "Subject Code," "Semester Type (Odd/Even)," and "Year of Examination."
3. Format Selection: Most resources are archived as PDF/A (Archival standard) to ensure long-term accessibility.
4. Subject Filtering: Filtering by department, such as Commerce, Science, or Arts, to isolate specific B.Com notes or B.Sc semester papers.

## Admission Mechanics and Eligibility Criteria (2024 Cycle)

The admission process at Assam University has undergone significant transformation with the adoption of the **Common University Entrance Test (CUET)**. This move aligns the university with the National Education Policy (NEP) 2020, standardizing the evaluation process for aspirants from

diverse boards.

### Step-by-Step Admission Procedure

- Phase 1: CUET Registration: Candidates must register through the NTA (National Testing Agency) portal, selecting Assam University as their target institution.
- Phase 2: Domain Selection: For courses like B.Com or B.Sc, specific domain subjects must be chosen according to the university's eligibility matrix.
- Phase 3: Result Normalization: Scores are processed using the Equipercentile Method to ensure fairness across multiple shifts of the exam.
- Phase 4: Institutional Counseling: Successful candidates participate in the university's internal counseling process, where seat allocation is based on rank, category, and availability.

Eligibility for UG courses typically requires a 10+2 qualification with a minimum aggregate of 45-50%, depending on the specific department and reservation norms. For PG programs, a relevant Bachelor's degree is mandatory.

### Technical Evaluation of Fee Structures and Financial Obligations

Assam University is known for maintaining an affordable fee structure, consistent with its mission as a central institution. However, students must account for varying costs between the Silchar and Diphu campuses, particularly regarding **Hostel Fees** and **Examination Charges**.
